DOCUMENTS – PREFERRED OPTIONS

This statement has been prepared under Regulation 26 of the Town and Country Planning (Local Development)(England) Regulations 2004 as part of North Hertfordshire District Council's Local Development Framework.

The Council is preparing two development plan documents, the Core Strategy and Development Policies, as part of the Local Development Framework. The Core Strategy DPD will provide the overall spatial vision, objectives and policies for the district up to 2021 whilst the Development Policies DPD will set out a series of detailed policies which will be used by the Council in determining the planning applications it receives. The policies in both documents will be applied across North Hertfordshire.

As part of this process the Council has produced Preferred Options documents and a Sustainability Appraisal report and is seeking representations on these proposals.
