APPLICATION FOR VARIATION	<p>This is an application for variation of a Premises Licence under Section 34 of the Licensing Act 2003.</p> <p>The Sub-Committee have read the material presented to us and have listened to all the evidence and submissions. The Sub-Committee has considered the National Guidance and the Statement of Licensing Policy and has come to the following decision:</p> <p>1. On this day the hours will be from 1200hrs to 0200hrs the following morning

PART F – Recorded Music

Wednesday to Sunday 1200hrs to 2300hrs

These hours are to apply each day of the year with the exception of:

- Xmas Eve,
- Xmas Day,
- Boxing Day,
- Good Friday, Easter Saturday, Easter Sunday, Easter Monday
- Spring and August Bank Holiday Mondays and the Friday, Saturday and Sunday preceding the Bank Holiday.

On all these days the hours will be from 1200hrs to 2300hrs

Also

- New Years Eve

On this day the hours will be from 1200hrs to 0200hrs the following morning

PART M – Supply of Alcohol

Sunday to Wednesday 1000hrs to 2400hrs

Thursday 1000hrs to 0100hrs the following morning

Friday and Saturday 1000hrs to 0200hrs the following morning

These hours are to apply each day of the year with the exception of:

- Xmas Eve,
- Xmas Day,
- Boxing Day,
- Good Friday, Easter Saturday, Easter Sunday, Easter Monday
- Spring and August Bank Holiday Mondays and the Friday, Saturday and Sunday preceding the Bank Holiday.

On all these days the hours will be from 1000hrs to 0200hrs

CONDITIONS DEEMED NECESSARY FOR THE PROMOTION OF THE LICENSING OBJECTIVES	<p>The Sub-Committee recognises that conditions will <u>only</u> be imposed on a licence where conditions are necessary for the promotion of one of the four licensing objectives. The Sub-Committee will only impose conditions on a licence where relevant representations have been made and they consider that it is necessary to impose conditions as a result of these representations.</p> <p>The Sub-Committee does not consider that it is necessary to impose any additional conditions on the premises in order to promote the licensing objectives.</p>
CONDITIONS PROPOSED BY THE RESPONSIBLE AUTHORITIES	<p>The following condition has been recommended by:</p> <p>Mr Mario Houska, Environmental Health Officer</p> <p>1. Live musical events shall only be carried out during December, January and February months.</p> <p>This condition is considered <u>unnecessary</u> to ensure the promotion of one of the four licensing objectives, namely the prevention of public nuisance.</p>
CONDITIONS PROPOSED BY APPLICANT	<p>This licence will be subject to the conditions, that are consistent with the terms offered by the applicant in order to promote the four licensing objectives set out in Part P of their application.</p> <p>No additional conditions were offered by the applicant during the course of the hearing.</p>
EFFECT OF FAILING TO COMPLY WITH CONDITIONS EXPLAINED TO APPLICANT	<p>The Sub-Committee has explained to the applicant the effect of failure to comply with any of the conditions attached to the licence or certificate is a criminal offence, which upon conviction, would result in a fine of up to £20,000 or up to six months imprisonment or both.</p>
STATEMENT OF LICENSING POLICY	<p>The Sub-Committee has taken into account the North Hertfordshire District Council's Statement of Licensing Policy in reaching their decision. They have found the following sections to be of particular relevance in reaching this decision.</p> <p>5. Licence Conditions</p> <p>5.1 The Council will tailor any conditions to the individual</p>

	<p><i>circumstances of the premises and events concerned and will seek to avoid attaching disproportionate and over burdensome conditions on licences.</i></p> <p>5.2 <i>Conditions will only be imposed when they are necessary for the promotion of the Licensing Objectives and will focus upon matters within the control of the individual licensee such as the premises, places or events being used for licensable activities. Conditions are likely to be focused towards the direct impact of those activities on persons living, working or otherwise engaged in activities in the vicinity.</i></p> <p>9. The Prevention of Public Nuisance</p> <p>9.1 <i>Licensed premises may have significant potential to impact adversely on communities through public nuisances that arise from their operation. The Council interprets 'Public Nuisance' in its widest sense and takes it to include such things as noise, light, odour, litter and anti-social behaviour, where these matters impact on those living, working or otherwise engaged in activities in the vicinity of a particular premises.</i></p> <p>10. Live Music, Dancing and Theatre</p> <p>10.1 <i>The Council recognises the need to encourage and promote live music, dancing and theatre for the wider cultural benefit of the community.</i></p> <p>10.2 <i>Only necessary, proportionate and reasonable licensing conditions will be imposed on relevant licences so as not to discourage the promotion of entertainment. Conditions will relate to the promotion of the Licensing Objectives.</i></p> <p>10.3 <i>The Council will avoid any measure, which deters live music, dancing and theatre by imposing indirect costs of a substantial nature.</i></p>
COMMENCEMENT DATE	This licence will come into effect from the date of this decision.
RIGHTS OF REVIEW	At any stage, following the grant of a premises licence, a responsible authority, such as the Police or an interested party, such as a resident living in the vicinity of the premises may ask the licensing authority to review the licence because of a matter arising at the premises in connection with any of the four licensing objectives. The review is a request for the Council to look at the existing licence and decide whether its conditions are adequate to meet the four licensing objectives defined under the Licensing Act 2003.
