On page 26 of OLP3 it refers to Rush Green which is described as free standing settlement of a thousand homes - like a new garden settlement. Rush Green was promoted by NHDC.

January 2018 – More representors highlight the fact of the legal entity called The New Garden City Company. It was factually incorporated by the Plan's signatory and Council's Chief Planning Executive; and therefore becomes a material consideration. It has now become a legal company and no longer "Conceptual". The representors argue that it should therefore be included in the Housing Economic Land Availability Assessment, Strategic Housing Market Assessment, Sustainability Assessment and Strategic Housing Market Assessment submitted to the Inspector. This may also be viewed for all intents and purposes, as potentially the new settlement vehicle itself. Therefore should it make appearance in the Plan document and be subjected to the same scrutiny as everything else, in order for the Plan to be robust?
