We would like the Local Plan Examination to ensure that there is sufficient planning between NHDC and Herts County

Council for the additional transport needs that will result from new housing. In particular, the capacity of access roads

that will be utilised to reach the A1/M, traffic increases in an East-West direction to employment area in Luton and

Stevenage and increased commuter traffic (with additional parking requirements).

For instance, Letchworth already has a number of access roads to the stations which are in effect one-way streets

because of commuter parking and any increase in commuters who drive to the station will worsen the situation. See



Statement

We would like the Local Plan Examination to ensure that there is sufficient planning between NHDC and Affinity Water

concerning the supply of fresh water and between NHDC and Anglian Water concerning sewerage. For the local plan to

be sound, water supplies for the new housing should be sourced without damaging the local chalk streams. Affinity

Water have recently published their draft Drought Plan and this indicates 'serious damage to the environment (recovery will take 12 years or more) in the event of a 2.5 year or more drought'. Consideration should be given to inviting

Affinity Water to the hearings to gain assurances that the local plan water requirements can be delivered without

environmental damage.
