**DISCLOSABLE PECUNIARY INTERESTS & DECLARABLE INTERESTS**

The Register of interests is maintained by the Monitoring Officer at North Hertfordshire District Council in accordance with section 29 of the Localism Act 2011. It is a Councillor's responsibility to notify the Monitoring Officer of their interests and keep the Register up to date within 28 days of election or appointment or of any changes.<sup>1</sup>
