"Prior to the commencement of development, a development and infrastructure phasing plan is to be submitted to and approved in writing by the LPA which must be agreed with the Local Authority in consultation with Thames Water. This plan is to set out the measures / works required to ensure that the local infrastructure has the capacity to serve the development and to allow the development to be occupied. Where a development and infrastructure phasing plan is agreed no occupation shall take place other than in accordance with the agreed development and infrastructure phasing plan. Reason: Sewage Treatment Upgrades are likely to be required to accommodate the proposed development. Any upgrade works identified will be necessary in order to avoid sewage flooding and/or potential pollution incidents."

#### "Condition 23

The development permitted by this planning permission shall be carried out in accordance with the following documents:

- E-mail response dated 23 August 2022 from Nolan Associates
- E-mail response dated 28 October 2022 from Nolan Associates
- Drainage Strategy carried out by Nolan Associates dated March 2022 reference 2021- 087
- CCTV and Connectivity Survey dated 9 May 2022 carried out by Wrc
- Manhole Survey Report dated 27 May 2022 carried out by Wrc

and the following mitigation measures:

- 1. Provide minimum surface water attenuation volume of 27m3 to ensure no increase in surface water run-off volumes for all rainfall events up to and including the 1 in 100 year + climate change (40%) event.
- 2. Implement drainage strategy based on a tank and permeable paving for attenuation and treatment at a discharge rate of 2l/s into an existing surface water sewer (final details to be confirmed as part of a post demolition condition).
- 3. Provide water quality treatment using permeable paving on 10 parking bays where all the impermeable areas including the access road will be directed to the permeable paving for treatment prior to discharge.

Reason To prevent flooding by ensuring the satisfactory storage of/disposal of surface water from the site.

#### Condition 24

No development shall take place, apart from the demolition of the current building, until the final design of the drainage scheme is completed and is approved by the LPA. The surface water drainage system will be based on the following approved documentation:

- E-mail response dated 23 August 2022 from Nolan Associates
- E-mail response dated 28 October 2022 from Nolan Associates

- Drainage Strategy carried out by Nolan Associates dated March 2022 reference 2021-087
- CCTV and Connectivity Survey dated 9 May 2022 carried out by Wrc
- Manhole Survey Report dated 27 May 2022 carried out by Wrc

The scheme shall also include:

- 1. Post demolition survey of the existing drainage system to confirm the existing connection into a sewer. Should the survey determine the connection is into an existing combined sewer, the applicant will need to demonstrate that they have considered other options where possible to connect into another surface water sewer.
- 2. Permission from Anglian Water to connect into their sewer including any required sewer upgrades due to capacity issues at the agreed rate of 2l/s.
- 3. Detailed engineered drawings of the proposed SuDS features including their location, size, volume, depth and any inlet and outlet features including any connecting pipe runs and all corresponding calculations/modelling to ensure the scheme caters for all rainfall events up to and including the 1 in 100 year + 40% allowance for climate change event.
- 4. Detailed engineered drawings of the tank and permeable paving parking areas. The drawing should also show proposed levels of how the access road and other hardstanding areas will drain into the permeable paved parking bays.
- 5. Demonstrate appropriate SuDS management and treatment and inclusion of above ground features such as permeable paving, reducing the requirement for any underground storage.
- 6. Provision of half drain down times for surface water drainage within 24 hours.
- 7. Silt traps for protection for any residual tanked elements.

Reason: To prevent flooding by ensuring the satisfactory storage of and disposal of surface water from the site."

#### 10 COUNCIL TAX REDUCTION SCHEME 2023/24

#### **RECOMMENDED TO CABINET:** To:

(1) Note that a full review of the Council Tax Reduction Scheme has taken place and that consultation with the public and Major Precepting Authorities has taken place.

- (2) Note the aim of the review has been to introduce a new scheme that will:
- enable us to increase the overall level of support for the lowest income households;
- reduce the administrative burden placed on the Council following the introduction of Universal Credit;
- make the scheme easier for our customers to understand and calculate entitlement.

(3) Recommend to Council that a new banded scheme for working age applicants is adopted from 01 April 2023.

(4) Recommend to Council the use of the Council Tax Hardship Grant to fund a discretionary scheme to provide additional transitional support where appropriate and that decisions regarding Discretionary support are delegated to the Service Director Customers in consultation with the Executive Member for Finance and IT.

(5) Note that the new scheme may increase the costs from those of the current scheme, any increase will be split between the Council and its Major Precepting Authorities. The Council's share is expected to be around 12.5%.

**REASON FOR DECISIONS:** To ensure that the Council has a fit for purpose Council Tax Reduction Scheme that:

- Provides the greatest support to the lowest income households;
- Reduces the administrative burden that has been placed on the Council since the introduction of Universal Credit (UC);
- Is simple to understand, meaning that customers will be able to calculate entitlement and assess the impact of potential changes in circumstances.

#### 11 ANNUAL REVIEW OF THE CONTRACT PROCUREMENT RULES

**RECOMMENDED TO COUNCIL:** That Council considers the proposed changes and recommends their adoption to Full Council.

**REASONS FOR DECISIONS:** Members are able to monitor, make adjustments within the overall budgetary framework and request appropriate action of Services who do not meet the budget targets set as part of the Corporate Business Planning process.

## 14 SECOND QUARTER INVESTMENT STRATEGY (CAPITAL AND TREASURY) REVIEW 2022/23

#### **RECOMMENDED TO CABINET:** That Cabinet:

(1) Note the forecast expenditure of £9.815M in 2022/23 on the capital programme, paragraph 8.3 refers.

(2) Approves the adjustments to the capital programme for 2022/23 onwards, as a result of the revised timetable of schemes detailed in table 2 and 3, increasing the estimated spend in 2023/24 by  $\pounds$ 0.861M and  $\pounds$ 2.0M in 2024/25

(3) Notes the position of the availability of capital resources, as detailed in table 4 paragraph 8.6 and the requirement to keep the capital programme under review for affordability.

(4) Recommends to Council that it notes the position of Treasury Management activity as at the end of September 2022.

(4) Notes the comments made at the budget workshops, and comment on the inclusion of the revenue savings and investments in the budget to be brought back for consideration in January, for referral on to Council in February;

(5) Notes the comments made at the budget workshops, and comment on the inclusion of the capital investments in the Investment Strategy to be brought back for consideration in January, for feral on to Council in February.

**REASON FOR DECISIONS:** To ensure that all relevant factors are considered in arriving at a proposed budget, Investment Strategy and Council Tax level for 2023/24, to be considered by Full Council on 23 February 2022.

#### 4. REASON FOR DECISION

At a Cabinet meeting on the 13 September and Full Council on 22 September 2022 a proposal to convert the dry side changing rooms (utilised by sports hall users), accessible toilet, and two squash courts into a soft play area at NHLC was discussed and agreed. The following minute details the resolutions;

**RESOLVED:** That Cabinet considered and agreed the soft play investment proposal.

#### **RECOMMENDED TO COUNCIL:**

## 6. CONSULTATION (INCLUDING THE EFFECT ON STAKEHOLDERS, PARTNERS AND THE PUBLIC)

Officers have consulted with the Executive Member – Environment and Leisure, Deputy Executive Member for Environment and Leisure and Stevenage Leisure Limited.

#### 7. FORWARD PLAN

7.1 This report contains a recommendation on a key Executive decision that was first notified to the public in the Forward Plan on 18 July 2022.

#### 8. BACKGROUND/ RELEVANT CONSIDERATIONS

8.1 The Council are calling off from the Scape Procure Regional Construction Framework of which North Hertfordshire District Council is a member. The value of the project falls within the remit of Conamar Building Services Limited.

#### 9. LEGAL IMPLICATIONS

- 9.1. North Hertfordshire District Council accessed the Scape Procure Regional Construction Framework on 26 July 2016. The Access Agreement roles over on a 12 monthly cycle and allows the Council to procure works and services covered by the Framework and to Call-Off in line with the same, subject to renewal of the Framework Agreement in accordance with The Public Contracts Regulations 2015.
- 9.2. The Openness of Local Government Bodies Regulations 2014 (No. 2095) require officers undertaking non-executive decisions to record (amongst other things) an award of a contract that materially affects the Council's position in a written delegated decision. At North Hertfordshire District Council, this is any award of a contract or financial decision, that is or is likely to be above £50,000. This contract

award is above £50K and therefore has to be confirmed and approved by the relevant officer taking the decision.

#### 10. FINANCIAL IMPLICATIONS

- 10.1. There are no revenue implications.
- 10.2. A project budget of £250,000 is included in the 2022/23 Capital Programme.
- 10.3. The value of the works contract to be carried out by Conamar is £281k. This is £31k over budget but within the tolerance limit for capital projects as stated in the Authority's Financial Regulations. The project's budget will be amended in the second quarter Investment Strategy report to reflect the increase in spend.

#### 11. **RISK IMPLICATIONS**

11.1 Delays and complications are always a risk with contracts for works given that some issues can only be discovered by intrusive inspection after commencement of the works.

#### 13. SOCIAL VALUE IMPLICATIONS

- 13.1 Scape Procure are procurement specialist, dedicated to creating efficiency and social value via the built environment. Objectives are set for delivery (in procurement or for delivery of programmes and projects) to establish a common standard of outcomes, and to ensure social value outcomes feature in every service offered by Scape Procure.
- 13.2 The Scape Procure Regional Construction Framework has the following social value targets set which supports the local economy :

#### Soft play coming to Letchworth

A brand new soft play facility is being built at <u>North Herts Leisure Centre</u> on Baldock Road following a public consultation.

Over 1,000 people responded to our survey in August, with overwhelming support for the proposal, which will have a toddler and junior area, plus provision for parties. There will also be seating and refreshments available.

The new facility will be an extension of the centre and convert two of the four squash courts and changing rooms located in the same area. While we appreciate this will lead to a reduction in the number of squash courts and changing space available, the remaining two squash courts and changing rooms offer adequate provision based on usage data.

91% of respondents to the survey either strongly agreed or were inclined to agree that the proposal would be a positive addition to the facilities at North Herts Leisure Centre. 66% of respondents indicated that their family would be likely to use a soft play facility at the leisure centre at least fortnightly, or more frequently.

Councillor Steve Jarvis, Executive Member for Environment and Leisure, said: "Introducing a soft play facility at North Herts Leisure Centre will enhance the range of leisure facilities on offer, providing a dedicated play space for families with toddlers and young children within the local area. The new facility will enable more people to use the centre, aiding the recovery of leisure facilities after the Covid pandemic. It's a great investment in our leisure portfolio for the benefit of all residents in the future."

Lee Medlock, Operations Director from Stevenage Leisure Ltd (SLL), which manages the council's leisure facilities on the council's behalf, added: "We are delighted to be working in partnership with North Herts Council on this exciting project, which will increase the range of activities on offer to our community. We are confident that the addition of the soft play facility

to North Herts Leisure Centre will provide a fun and exciting opportunity for children to play and increase their physical activity levels."

The soft play facility is due to open for the Easter holidays next year and will cost  $\pounds 250$ k, with  $\pounds 100$ k being reallocated from the planned refurbishment of the changing rooms which will now be part of the conversion.
