

## RECORD OF DECISION MADE UNDER DELEGATED AUTHORITY

#### **1. DECISION TAKEN**

To set the fees for the financial year 2023/24 as detailed in Appendix A.

#### **3. DATE DECISION TAKEN:**

24 February 2023

#### **4. REASON FOR DECISION**

- 4.1 To ensure that the Council recovers its reasonable costs of undertaking its licensing function as provided for within legislation.

#### **5. ALTERNATIVE OPTIONS CONSIDERED**

- 5.1 No other alternatives were considered as the decision is based upon the requirements of the Council's Medium Term Financial Strategy, the legislative requirements of *Hemming*<sup>1</sup> and a minute of the Licensing and Appeals Committee (now renamed the Licensing and Regulation Committee) outlining the parameters to be applied when setting fees.

#### **6. CONSULTATION (INCLUDING THE EFFECT ON STAKEHOLDERS, PARTNERS AND THE PUBLIC)**

- 6.1 The Executive Member for Housing and Environmental Health, and Deputy, has been consulted and supports the decision.
- 6.2 The new taxi and private hire fees will be subject to mandatory public consultation.

#### **7. FORWARD PLAN**

- 7.1 This decision is not a key Executive decision and has therefore not been referred to in the Forward Plan.

#### **8. BACKGROUND/ RELEVANT CONSIDERATIONS**

- 8.1 The key consideration was compliance with the Licensing and Appeals Committee minutes setting out the parameters to be followed when setting fees, whilst adhering

to the *Hemming*<sup>2</sup> judgement restricting Council's to recovering reasonable costs only.

**RESOLVED:** That, having considered the criteria suggested within the report, the following principles for the setting of future licensing fees and charges be supported:

- (a) *licensing fees and charges should be set having regard to the need to promote local economic growth provided that they are consistent with the following objectives:*
  - (i) *That the local Council Tax payers does not, unless provided for by law or decision of the Council, subsidise the operating costs associated with businesses or other trading entities (i.e. the Council seeks to fully recover the lawful costs licensing activity);*
  - (ii) *the Council may not fully recover its lawful costs associated with licensing activity if a) this would result in significant hardship to third parties, or b) the effect of fees or charges associated with licensing may encourage unlicensed activity and where formal enforcement is unlikely to be an effective control, or c) where the Council specifically wishes to encourage the growth a specific licensable activity;*
- (b) *an analysis of licensing costs, including detailed analysis of all recharges, should be undertaken every three years vis-à-vis licensing fees and charges;*
- (c) *in the years between cost reviews, fees and charges should ordinarily be subject to the Council's published inflationary increase;*
- (d) *any under/over recovery of full cost within existing licensing fees and charges should be rectified without undue delay, where legislation allows. However, where this may result in a significant increase in a licence fee/charge then consideration will be given to a phased introduction of the new levy;*
- (e) *that enforcement activities in respect of unlicensed businesses/individuals should continue with the associated costs being financed from the General Fund; and*
- (f) *that enforcement activities are periodically reviewed to ensure that they are delivered in the most cost effective manner including, where appropriate, the use of other internal departments or external statutory bodies.*

8.2 A full costing using hourly rates supplied by the Accounts team was undertaken for those fees set at a local level to ensure that all reasonable costs of administration, and enforcement, where permitted by legislation, were included. The fee breakdown analysis is set out at Appendix A.

### **Hackney carriage and private hire vehicle, driver and operator licences**

- 8.3 The decision on these fees is provisional pending the result of a public consultation. The legislation provides for the fees to be advertised to take effect from a specified date in the absence of any representations. If representations are received, they must be considered and either the fees amended or confirmed without further consultation.
- 8.4 Further efficiencies in the way that applications are processed have enabled the fee for vehicle licences to be reduced further, making this the fourth annual reduction in fees for vehicle licence holders. Considerable work with the licensed trade has been undertaken to provide a more efficient service with a move to more self-service style applications. The trade has worked with the Council to achieve this with the knowledge that fee reductions may be possible given the legislation prohibiting a profit to be made on fees.
- 8.5 The increase in driver licence fees, despite some administrative savings, is the result of additional checks that the Council must undertake prior to the grant/renewal of a licence. It now checks the applicant's right to work status, that they are registered with HMRC, and that they do not appear on the national database of revocations and refusals.

- 8.6 To encourage the trade to move towards more environmentally friendly vehicles, a discounted licence fee was introduced in 2019 for electric and hybrid vehicles for the first time. As the Council has declared a climate change emergency, this decision is consistent with the parameters set out by the then Licensing and Appeals Committee (now Licensing and Regulation) resolution and it is suggested that this continues for a further year. This will assist vehicle licence holders as we move towards the Council's Policy of uLEV licensed vehicles from 2028.

### **Animal licences**

- 8.7 A change in animal licensing legislation in September 2018 had led to a considerable increase in costs occurred when administering and enforcing animal licences, resulting in higher licence fees when first set in 2019.
- 8.8 A significant part of this work was being undertaken by Central Bedfordshire Council due to the lack of in-house expertise however a senior licensing officer has now completed a professional qualification that has brought this task back in-house. This has reduced the cost of undertaking inspections for the Council, therefore allowing a reduction in licence fees.

### **Processes transferring from Environmental Health to Licensing**

- 8.9 Skin piercing (including tattooing, piercing, electrolysis, acupuncture) was transferred to the licensing team from 1 April 2022 therefore a new fee costing was undertaken, including provision for upskilling the senior licensing officer. As the senior officer has developed experience in this area, the licence cost has reduced.
- 8.10 The licensing of park homes and houses of multiple occupation was transferred to the licensing team from 1 April 2022. The fees for 2023/23 were based on the previous year's fees plus an inflationary increase. As no new applications have been received for these licence types, a full costing exercise has not yet been possible therefore it is proposed to extend the 2022/23 fees to 2023/24. The normal inflationary increase would be offset by the reduction in officer hourly rate from an environmental health officer to a licensing officer. A full costing exercise will be undertaken when the next applications are received.

### **Other licence fees**

- 8.11 Further smarter ways of working are being investigated to ensure a balance between best value for our customers and full cost recovery of the Council's costs where legislation allows.

## **9. LEGAL IMPLICATIONS**

- 9.1 Section 14.6.4 (a) (viii) of the Council Constitution delegates the following powers to the Managing Director and the Service Directors:

*To set fees and charges in accordance with the Council's Financial Regulations and relevant policies, in consultation with the Executive Member*

- 9.2 Section 14.6.8 (b) (xii) further delegates the Service Director: Legal and Community:

*Licensing including all functions under all relevant Licensing legislation other than matters reserved to the Licensing and Regulation Committee and Full Council.*

- 9.3 The setting of fees is predominately a Council function by virtue of Regulation 2(6) of the Local Authorities (Functions and Responsibilities) (England) Regulations 2000, as amended, which states:

*(e) where a charge is made for any such approval, consent, licence, permit or registration, the amount of the charge, is not to be the responsibility of an executive of the authority.*

- 9.4 As the Scrap Metal Dealers Act 2013 and the Animal Welfare Act 2006 are not included within Schedule 1 of the Local Authorities (Functions and Responsibilities) (England) Regulations 2000, as amended, the setting of fees for these licences is an Executive function by virtue of section 9D of the Local Government Act 2000.

## **10. FINANCIAL IMPLICATIONS**

- 10.1. This decision ensures that the Council recovers the maximum amount of its reasonable costs associated with this licensing function as provided for in legislation.
- 10.2 A number of the fees have reduced from previous levels due mainly to smarter ways of working that have resulted in a more streamlined and cost-effective way of administering applications.
- 10.3 Whilst the licensing income budget will initially decrease, lower fees may contribute to more applications being received.
- 10.4 The smarter ways of working will free more resource to focus on additional income generation through discretionary licensing services not subject to *Hemming*<sup>3</sup>, and undertake more customer engagement to increase public involvement in licensing.

## **11. RISK IMPLICATIONS**

- 11.1 The risk to the Council of not taking this decision is that the Council would be under or over recovering reasonable costs associated with its licensing function.
- 11.2 Over recovery of costs associated with licensing would be unlawful as a result of the *Hemming*<sup>4</sup> case.
- 11.3 Under recovery of costs associated with licensing would mean that businesses are being subsidised from Council funds.

## **12. EQUALITIES IMPLICATIONS**

- 12.1 In line with the Public Sector Equality Duty, public bodies must, in the exercise of their functions, give due regard to the need to eliminate discrimination, harassment, victimisation, to advance equality of opportunity and foster good relations between those who share a protected characteristic and those who do not.
- 12.2 There are no equalities implications as a result of this decision.

## **13. SOCIAL VALUE IMPLICATIONS**

- 13.1 The Social Value Act and “go local” policy do not apply to this decision.

## **14. ENVIRONMENTAL IMPLICATIONS**

- 14.1. There are no known Environmental impacts or requirements that apply to this decision, other than confirming the Council’s aim through the fee structure to support

## LICENCE FEES

Following the decision of the Supreme Court in *R. (on the application of Hemming (t/a Simply Pleasure Ltd)) v Westminster City Council* and the subsequent referral of one point of law to the European Court of Justice, clarity was provided under the EU Services Directives on licensing fees through the Provision of Services Regulations 2009. At the point of setting these fees, however, it is unclear how the Retained EU Law (Revocation and Reform) Bill 2022-23, if implemented, will affect the EU Services Directives - but applies as at the point of setting the fees.

The law now precludes any requirement at the time of application for the payment of a fee relating to anything other than the authority's cost of processing and determining the application. The authority's costs of enforcement and ongoing management of a licence should be subject to a separate fee which becomes payable once the licence has been granted and prior to the licence being issued.

This does not preclude an applicant from paying both parts of the fee at the time of application however the authority is precluded from making this a requirement.

The authority will now split licence fees that are subject to the EU Services Directive into two parts as follows:

### Application Fee

Payable at the time of application representing the authority's costs in processing and determining the application. This fee would not be refundable should an application be unsuccessful.

### Licence Fee

Payable upon the grant of the application, but prior to the issue of the licence, representing the authority's costs of ongoing enforcement and maintenance of the licensing regime. This fee would be refundable, where paid in advance, if the application was not successful.

### NOTES

Hackney carriage and private hire licensing falls outside the remit of the EU Services Directive. Fees in connection with hackney carriage and private hire licensing are defined in legislation as licence fees as they are payable for the grant of a licence not for the processing of an application.

Gambling licensing falls outside the remit of the EU Services Directive. Fees in connection with gambling licensing are defined as application fees as the legislation makes no provision for refunding the fee in the event of an unsuccessful application.

Fees under the Licensing Act 2003 which are set centrally by Government are defined as application fees as the legislation makes no provision for refunding the fee in the event of an unsuccessful application.
