Community Engagement Executive Member briefing – February 2023

Community Protection

Community Safety

- The VAWG event was held at Hitchin Town hall on Sunday 15th January, which was well attended and well received, and an event that we will look to redo later in the year.
- There was an unauthorised encampment of European travellers at Woodside car park, Walsworth Road, Hitchin on Thursday 9th February. This led to multiple complaints from local residents and businesses. Procedures commenced immediately to remove the encampment and on Saturday 11th February the Travellers moved on without issue.
- Environmental crime officers and local police have recommenced joint high visibility proactive patrolling, engaging with the rural communities and farmers to provide reassurance and support. These have been well received by the public and involved North Herts Council recovering a vehicle that had been used to cause nuisance and crime in the rural areas. These are going to be an ongoing feature, in the coming months.

<u>Health & Wellbeing /Safeguarding</u> <u>briefing February 2023</u>

- The Healthy Hub drop-ins in are now scheduled to the end of March 2023.
 Further information can be found HERE
- Throughout January, the Healthy Hub offered an after school Warm Space in Royston with free kids' activities, drinks and snacks for families. Take up was low so the pilot won't be continued.
- The new Safeguarding Team (Lisa Mcdonnell and Lisa Mcdonald) are rolling out a programme of training and contacting all staff and members who are due to complete safeguarding training or undertake their three yearly refresher.
- Funding applications have been submitted to the lottery for physical activity programmes for older people and a physical and mental health project for men in the Jackman's Active Local area.
- Following a successful bid to Health Protection Board with Mind Mid Herts, a part time outreach worker has been deployed in Royston to offer 1:1 and peer group support.

Throughout January and February, the team have been busy coordinating various partnership networks and events and the provision of ongoing Community and Member support.

- Hosted Holocaust Memorial Day event in the Council Chamber.
- Coordinating and supporting the first Baldock Councillors Surgery.
- Working with various groups to support asylum seekers in Baldock and Hitchin.
- Coordinating judging panel for North Herts Heroes (Chair's Awards).
 Coordinating filming of winners/groups.
- Support for events including Hitchin Youth Showcase (to be held in September) and Baldock Beast.
- Planning and coordination of Cabinet Panel Community Engagement and Enterprise.
- Preparation for 22 February Environment Panel meeting which will be a roundup of our achievements across various areas include biodiversity, planning, carbon saving projects, and transport.
- Leading on HCCSP's biodiversity subgroup and a revision of the strategic action plan. This has included an invite for relevant community groups and other organisations to attend subgroup meetings to share their expertise and help shape the action plans at an early stage.
- Continued monitoring of the Solar Together scheme and the Sustainable Warmth scheme.
- Meeting with CDA Herts to discuss needs in rural areas and ways of working together.

Electoral Services

- The team has successfully delivered the Hitchin North County by-election on Thursday 9 February 2023. The Declaration of Results can be found on our website <u>Election results 2023 |</u> North Herts <u>Council</u> (northherts.gov.uk)
- We have also undertaken the postal vote signature refresh exercise, where all postal voters who applied 5 years ago must refresh their signatures each January. We sent out around 1500 such letters and around 1000 have been returned for scanning and processing.
- Preparation for the May 2023 elections is also underway – polling station facilities are being reviewed, staffing appointments made and we are making arrangements for briefings with candidates and agents.
- Furthermore, we are preparing for the Elections Act changes. Electors may now apply for a free voter authority certificate if they do not already have appropriate ID and we have now been issued with updated Electoral Commission guidance for polling station staff.
- Finally, our new Democratic Services Apprentice Callum has started with the team on Monday 13 February.

Committee Services

- The new CMSO is due to start on 28th
 February. The last round of recruitment
 was not successful, with two interviews
 and neither offered a role. Next round
 of recruitment likely to take place after
 Member induction in May 2023.
- Continuing progress on an SLA with Auditel and fallback options if the AV system fails in future. Exploring options of installation of an AV system in Committee Rooms 2 & 3 so smaller meetings can take place outside of the Chamber
- A formal Chair's Civic event will not take place this year, but instead a fundraising link will be set up and circulated to Members at North Herts, as well as to the other Chairs and ceremonial leaders from neighbouring authorities.
- Starting to look at the Members Induction programme, which is scheduled to take place from 9-19 May 2023 and will be a mixture of in person and virtual sessions.

5.1 No other alternatives were considered as the decision is based upon the requirements of the Council's Medium Term Financial Strategy, the legislative requirements of *Hemming*¹ and a minute of the Licensing and Appeals Committee (now renamed the Licensing and Regulation Committee) outlining the parameters to be applied when setting fees.

6. CONSULTATION (INCLUDING THE EFFECT ON STAKEHOLDERS, PARTNERS AND THE PUBLIC)

- The Executive Member for Housing and Environmental Health, and Deputy, has been consulted and supports the decision.
- 6.2 The new taxi and private hire fees will be subject to mandatory public consultation.

7. FORWARD PLAN

7.1 This decision is not a key Executive decision and has therefore not been referred to in the Forward Plan.

8. BACKGROUND/ RELEVANT CONSIDERATIONS

8.1 The key consideration was compliance with the Licensing and Appeals Committee minutes setting out the parameters to be followed when setting fees, whilst adhering

to the *Hemming*² judgement restricting Council's to recovering reasonable costs only.

RESOLVED: That, having considered the criteria suggested within the report, the following principles for the setting of future licensing fees and charges be supported:

- (a) licensing fees and charges should be set having regard to the need to promote local economic growth provided that they are consistent with the following objectives:
 - (i) That the local Council Tax payers does not, unless provided for by law or decision of the Council, subsidise the operating costs associated with businesses or other trading entities (i.e. the Council seeks to fully recover the lawful costs licensing activity);
 - (ii) the Council may not fully recover its lawful costs associated with licensing activity if a) this would result in significant hardship to third parties, or b) the effect of fees or charges associated with licensing may encourage unlicensed activity and where formal enforcement is unlikely to be an effective control, or c) where the Council specifically wishes to encourage the growth a specific licensable activity;
- (b) an analysis of licensing costs, including detailed analysis of all recharges, should be undertaken every three years vis-à-vis licensing fees and charges;
- (c) in the years between cost reviews, fees and charges should ordinarily be subject to the Council's published inflationary increase:
- (d) any under/over recovery of full cost within existing licensing fees and charges should be rectified without undue delay, where legislation allows. However, where this may result in a significant increase in a licence fee/charge then consideration will be given to a phased introduction of the new levy;
- (e) that enforcement activities in respect of unlicensed businesses/individuals should continue with the associated costs being financed from the General Fund; and
- (f) that enforcement activities are periodically reviewed to ensure that they are delivered in the most cost effective manner including, where appropriate, the use of other internal departments or external statutory bodies.
- 8.2 A full costing using hourly rates supplied by the Accounts team was undertaken for those fees set at a local level to ensure that all reasonable costs of administration, and enforcement, where permitted by legislation, were included. The fee breakdown analysis is set out at Appendix A.

Hackney carriage and private hire vehicle, driver and operator licences

- 8.3 The decision on these fees is provisional pending the result of a public consultation. The legislation provides for the fees to be advertised to take effect from a specified date in the absence of any representations. If representations are received, they must be considered and either the fees amended or confirmed without further consultation.
- 8.4 Further efficiencies in the way that applications are processed have enabled the fee for vehicle licences to be reduced further, making this the fourth annual reduction in fees for vehicle licence holders. Considerable work with the licensed trade has been undertaken to provide a more efficient service with a move to more self-service style applications. The trade has worked with the Council to achieve this with the knowledge that fee reductions may be possible given the legislation prohibiting a profit to be made on fees.
- 8.5 The increase in driver licence fees, despite some administrative savings, is the result of additional checks that the Council must undertake prior to the grant/renewal of a licence. It now checks the applicant's right to work status, that they are registered with HMRC, and that they do not appear on the national database of revocations and refusals.

8.6 To encourage the trade to move towards more environmentally friendly vehicles, a discounted licence fee was introduced in 2019 for electric and hybrid vehicles for the first time. As the Council has declared a climate change emergency, this decision is consistent with the parameters set out by the then Licensing and Appeals Committee (now Licensing and Regulation) resolution and it is suggested that this continues for a further year. This will assist vehicle licence holders as we move towards the Council's Policy of uLEV licensed vehicles from 2028.

Animal licences

- 8.7 A change in animal licensing legislation in September 2018 had led to a considerable increase in costs occurred when administering and enforcing animal licences, resulting in higher licence fees when first set in 2019.
- A significant part of this work was being undertaken by Central Bedfordshire Council due to the lack of in-house expertise however a senior licensing officer has now completed a professional qualification that has brought this task back in-house. This has reduced the cost of undertaking inspections for the Council, therefore allowing a reduction in licence fees.

Processes transferring from Environmental Health to Licensing

- 8.9 Skin piercing (including tattooing, piercing, electrolysis, acupuncture) was transferred to the licensing team from 1 April 2022 therefore a new fee costing was undertaken, including provision for upskilling the senior licensing officer. As the senior officer has developed experience in this area, the licence cost has reduced.
- 8.10 The licensing of park homes and houses of multiple occupation was transferred to the licensing team from 1 April 2022. The fees for 2023/23 were based on the previous year's fees plus an inflationary increase. As no new applications have been received for these licence types, a full costing exercise has not yet been possible therefore it is proposed to extend the 2022/23 fees to 2023/24. The normal inflationary increase would be offset by the reduction in officer hourly rate from an environmental health officer to a licensing officer. A full costing exercise will be undertaken when the next applications are received.

Other licence fees

8.11 Further smarter ways of working are being investigated to ensure a balance between best value for our customers and full cost recovery of the Council's costs where legislation allows.

9. LEGAL IMPLICATIONS

- 9.1 Section 14.6.4 (a) (viii) of the Council Constitution delegates the following powers to the Managing Director and the Service Directors:
 - To set fees and charges in accordance with the Council's Financial Regulations and relevant policies, in consultation with the Executive Member
- 9.2 Section 14.6.8 (b) (xii) further delegates the Service Director: Legal and Community:
 - Licensing including all functions under all relevant Licensing legislation other than matters reserved to the Licensing and Regulation Committee and Full Council.
- 9.3 The setting of fees is predominately a Council function by virtue of Regulation 2(6) of the Local Authorities (Functions and Responsibilities) (England) Regulations 2000, as amended, which states:

- (e) where a charge is made for any such approval, consent, licence, permit or registration, the amount of the charge, is not to be the responsibility of an executive of the authority.
- 9.4 As the Scrap Metal Dealers Act 2013 and the Animal Welfare Act 2006 are not included within Schedule 1 of the Local Authorities (Functions and Responsibilities) (England) Regulations 2000, as amended, the setting of fees for these licences is an Executive function by virtue of section 9D of the Local Government Act 2000.

10. FINANCIAL IMPLICATIONS

- 10.1. This decision ensures that the Council recovers the maximum amount of its reasonable costs associated with this licensing function as provided for in legislation.
- 10.2 A number of the fees have reduced from previous levels due mainly to smarter ways of working that have resulted in a more streamlined and cost-effective way of administering applications.
- 10.3 Whilst the licensing income budget will initially decrease, lower fees may contribute to more applications being received.
- 10.4 The smarter ways of working will free more resource to focus on additional income generation through discretionary licensing services not subject to *Hemming*³, and undertake more customer engagement to increase public involvement in licensing.

11. RISK IMPLICATIONS

- 11.1 The risk to the Council of not taking this decision is that the Council would be under or over recovering reasonable costs associated with its licensing function.
- 11.2 Over recovery of costs associated with licensing would be unlawful as a result of the *Hemming*⁴ case.
- 11.3 Under recovery of costs associated with licensing would mean that businesses are being subsidised from Council funds.

12. EQUALITIES IMPLICATIONS

- 12.1 In line with the Public Sector Equality Duty, public bodies must, in the exercise of their functions, give due regard to the need to eliminate discrimination, harassment, victimisation, to advance equality of opportunity and foster good relations between those who share a protected characteristic and those who do not.
- 12.2 There are no equalities implications as a result of this decision.

13. SOCIAL VALUE IMPLICATIONS

13.1 The Social Value Act and "go local" policy do not apply to this decision.

14. ENVIRONMENTAL IMPLICATIONS

14.1. There are no known Environmental impacts or requirements that apply to this decision, other than confirming the Council's aim through the fee structure to support

Council Tax Reduction Scheme proposals approved to help those who need it most

At a meeting of Full Council last month, North Herts Council approved changes to its Council Tax Reduction scheme, following a full review and consultation with residents in September 2022.

A new banded scheme for working age applicants will come in to force from 01 April 2023 and will provide 100% Council Tax Relief to the lowest income households across the district.

In terms of the impact of the new scheme, over 80% of residents who are currently receiving council tax reduction will either see an increase in the reduction they receive to their bill or will receive the same reduction. 18% of residents will receive a smaller reduction or will no longer be eligible if their income is too high.

The headline results from the consultation revealed that:

- 68% of residents said that they supported the introduction of an Income Grid scheme to replace the current scheme for all applicants of working age
- 90% agreed that any new claim or change in circumstances which changes Council
 Tax Reduction entitlement will be made from the date on which the change occurs,
 (rather than on a weekly basis as at present)
- 88% agreed with the proposal to protect disabled persons by disregarding Personal Independence Payments or Disability Living Allowance and providing a further disregard of £50 per week where the applicant, partner or dependant is in receipt of the disability benefit.

The new simplified support scheme will make it easier for customers to calculate their entitlement, which goes towards helping the council meet its People First priority. The

scheme will also reduce the administration involved, therefore making it quicker to process claims and reducing costs for the council.

Under the proposals, a single person with an income up to £100 per week, or a couple with two children on a weekly income below £260, will be entitled to the full 100% council tax relief. However, some families with an income below £515 a week will still be eligible for some support. The scheme for pension age residents is set by Government and will continue to remain unchanged.

The council will write to anyone who is likely to see a reduction in entitlement and will signpost to a discretionary scheme to provide additional support where appropriate.

Cllr Ian Albert, Executive Member for Finance and IT at North Herts Council said: "Thanks to everyone who took the time to give us their views.

"These are difficult times for our residents through the current cost of living crisis."

"I am delighted that this new scheme has been approved which will enable the Council to give more help to the people who need it most; as well as making it easier for people to calculate their entitlement and for the council to process claims more quickly."

At the Full Council meeting, Council also approved the use of the Council Tax Hardship Grant to fund a discretionary scheme to provide additional support where appropriate.
