#### North Herts Museum

North Herts Museum has enjoyed a very successful summer, with its visitor numbers in August totalling the third highest month of all time at North Herts Museum (behind the opening month and the first month of the Rembrandt exhibition). This again signals a strong recovery from the pandemic, however it should be noted that previous years have seen more family exhibitions whilst 23/24 will see a greater emphasis on artistic exhibitions in an effort to provide a diverse range of exhibitions. It is likely that as a result of this the overall numbers for 23/24 will visitor suppressed in comparison with previous annual totals.

North Herts Museum played its part in a nationwide project engaging schools and families across the country in a celebration of UK wildlife and creativity.

For its part, North Herts Museum engaged with Young Carers Crew to create a series of animations, hosted adult and kids craft classes and provided several additional school sessions.

The Wild Escapes Exhibition then presented the works created within our Terrace Gallery.

An exhibition on Peter Rabbit took place following Hitchin Art Clubs exhibition ended in June.



The exhibition helped to draw in families over the school summer break and assisted us in bringing in over 4000 visitors during August.

The summer break also saw a number of craft sessions, some of which were related to the exhibition, and which were offered at various price points. Virtually all the sessions sold out seeing our highest uptake ever in terms of holiday craft sessions.

#### Hitchin Town Hall

Hitchin Town Hall has seen the annual anticipated dip in usage which has become typical of the August summer break however the venue has still hosted several weddings, a drag brunch, some children's events such as the summer disco and a music night prior to the end of July summer break which proved popular.

September is on course to be the best month ever seen at the venue in terms of revenue, with a wrestling event, 2 music nights, a Jersey Boys tribute evening, a boxing event and a 3-day booking for filming taking place alongside all of the regular usage of the facility.

In what is perhaps early indication that our new website is beginning to bear fruit, we have seen a steady increase in the takeup of events tickets, with many selling out completely well ahead of time. Officers are optimistic that this trend will continue as the diverse range and frequency of events programmed at the venue increases.

Alongside these events, the team at the venue continue to promote the services offered at Hitchin Town Hall via our new website and social media.

#### Churchgate Shopping Centre

The team are awaiting the next Project Board meeting to take place on 17th October. The board meeting will consist of a presentation from consultants. Lambert Smith Hampton, on their findings so far. This will include a 'Review of Ownership, Planning Policy Overview and Market Overview'. The presentation and its findings will then be presented more widely to the rest of the Council later likely to be end October-mid November (the team are working on a date now). The next stage will consist of stakeholder engagement, that will see the consultants host a series of workshops, presentations and face to face meetings with key stakeholders inclusive of Hitchin Market Limited. The team are also working on a plan to engage with new and current tenants on their offering in the build up towards the festive period. This was delivered by the Communications team last year and was a proven success therefore we are looking to 'spotlight' a series of the Churchgate businesses again this year.

#### **Enterprise Strategy**

The team are currently working on the contents of the above strategy. The strategy will be a refreshed version of the current Commercial Strategy, and will incorporate three strands: Commercial, Economic Development and Tourism. The strategy will focus on the change in environment, budget constraints, ambitions of the Council, large projects (Churchgate) and a longer-term vision of what Enterprise looks like at North Herts Council now.

#### Shared Prosperity Fund

Under the Communities and Place Strand, the first grants have been sent to the three BIDs and Royston Town Council. The money was distributed across participating towns and include projects such as:

- Aesthetic improvements to Hitchin Market
- A new website for the Hitchin BID
- Installation of more planters
- Purchase of event equipment
- Employee event training
- A new website for Letchworth BID
- Pigeon deterrence
- More hanging baskets
- Repainting of street furniture in Royston.

We have also appointed 'People and Places' for 18 months to undertake follow up work to the Town Centre studies they produced. This is to help Letchworth, Baldock and Royston Stakeholders put together and launch their town improvement programmes. People and Places have been working with Letchworth Garden City initially and look to extend their work to the other two towns over the next few months.

The Moving Forward Together Programme has recommenced. Originally funded by the Community Wealth Fund in 2021/2, the consortium of Create Communities, NH Citizens Advice and NH and Stevenage CVS looks to help people who have become disengaged with society to become active in the community, through training, mentoring and volunteering. The revised programme also aims to work with NH VCSEs to increase their capacity and resilience, as many of our voluntary organisations are small and lack the systems and knowledge to expand their activities.

We are also finalising details of our arrangements with the Herts LEP regarding funding for Business and Skills support over the next two years under the Shared Prosperity Scheme.

#### **BID Renewals**

Economic Development has coordinated the BID renewal process and the Cabinet has now approved the renewal ballots to go ahead for the three BIDs. The (final) Ballot Days are 30<sup>th</sup> November for Royston, and 7<sup>th</sup> December for Hitchin and Letchworth. The BID Prospectuses have been approved and are being finalised by the BIDs prior to publication.

#### Disability Confident Event

North Herts and Stevenage Councils are holding a joint event on the 9<sup>th of</sup>
November 2023 with HCC Step 2 Skills to promote the Disability Confident
Programme to businesses in the districts.

Review of the number of District Councillors, Wards and Ward Names by the Local Government Boundary Commission for England

#### The Order has been Made!

In 2021 the Local Government Boundary Commission for England commenced an electoral review of the number of District Councillors, Wards and Ward Names.

The review has concluded, and the Order for North Hertfordshire has been made:

http://www.legislation.gov.uk/id/uksi/2023/1024.

These changes take affect from the elections in May 2024.

Starting from next year's local elections, all district councillors will be elected at the same time (rather than by thirds):

- 51 district councillors (currently there are 49)
- 25 wards (currently there are 24)
- 5 one councillor wards, 14 two councillor wards and 6 three councillor wards (currently there are 7 one councillor wards, 9 two councillor wards and 8 three councillor wards)

As a consequential affect of the Review, the Commission revised the electoral arrangements for Bygrave Parish Council and Royston Town Council:

- Bygrave Parish Council Bygrave East (4 Parish Councillors) and Bygrave West (1 Parish Councillor)
- Royston Town Council to be represented by 6 wards: Royston Garden Lane (1 Town Councillor); Royston Meridian (5 Town Councillors); Royston Palace (4 Town Councillors); Royston South (1 Town Councillor); Royston West (3 Town Councillors) and Royston Willowside (1 Town Councillor)

#### **Review of Polling Districts and Polling Places 2023**

#### Consultation opens – 2 October

The Council must conduct a full review of its polling districts and polling places for UK parliamentary constituencies that sit within North Hertfordshire by 31 January 2025, and thereafter every five years from the 1 October 2028.

The last full review was completed in October 2019.

In addition, following a district ward boundary review by the Local Government Boundary Commission for England, there have been changes to Ward boundaries and the numbers of councillors per ward in North Herts.

This change means we have to reconsider the location and the accessibility of our polling districts and polling places and we would like to hear your views.

#### **Definitions used in a Polling Place Review**

**Polling District** - the geographical area created by sub-dividing an electoral area. All wards within North Hertfordshire are divided into polling districts, which form the basis upon which the register of electors is produced. Unless there are special circumstances, each parish must be in a separate polling district.

**Polling Place** - the designated area in which a polling station is located, such as a particular building.

**Polling Station** - the room or area within the polling place where the process of voting takes place, e.g., a room in a community centre or school.

Please note that during this review, we will not be considering ward boundaries, divisions or parliamentary constituencies.

When conducting the review, we will use the guidance and resources published by the Electoral Commission:

Reviews of polling districts, polling places and polling stations | Electoral Commission

The consultation begins on 02 October and will run until 30 October and will be promoted via the Council's website; social media channels and our e-newsletter.

#### 1. DECISION TAKEN

Decision to award a contract to Technology One Limited for the provision an integrated Financial Management and Income Management Software for a period of 10 years with the option to extend for a further 5 years.

#### 4. REASON FOR DECISION

4.1 Technology One Limited provided the most economically advantageous bid for the Council, following an Open Procurement procedure.

#### 5. ALTERNATIVE OPTIONS CONSIDERED

5.1 We could have looked to extend contracts for the current software that we have. However, it had become clear that they were not offering the levels of automation that we were after, even after carrying out upgrades to their latest versions. It had also become clear that there would be significant cost increases from continuing with one of the current pieces of software, as the current contract was let 10 years ago and did not have any inflationary increases over that time.

### 6. CONSULTATION (INCLUDING THE EFFECT ON STAKEHOLDERS, PARTNERS AND THE PUBLIC)

6.1 The Executive Member for Finance and IT has been consulted on this decision. Cabinet (19/09/2023) and Council (28/09/2023) have approved the Capital spend of £200k in 2023-24.

#### 7. FORWARD PLAN

7.1 The award of the contract (due to the overall value of the contract) is a key executive decision (although it is delegated to Officers) and this was first notified to the public in the Forward Plan on the 26/05/2023.

#### 8. BACKGROUND/ RELEVANT CONSIDERATIONS

8.1 The Council has two main pieces of software that currently make up the overall system that enables it to record and manage payments, income and other financial transactions. These are:

- Integra Financials (Centros)- a financial management system that records transactions to enable payments, budget-setting, budget management and financial reporting.
- Civica Pay- for the collection and management of payments. This includes enabling customers to make payments on our website and over the phone.
- 8.2. The Council has had various iterations of the Integra software since 1998 and Civica since 2013. All of the transactions within Civica need to be integrated into Integra. There are currently a number of processes in place to enable this. This provided a driver to look for a solution that was either one piece of software or separate software that had complete integration. Market research had also identified that alternative options would offer other advantages in relation to user experience, customer experience, other process automation and improved reporting.
- 8.3. Integra is hosted on-site and has its own on-site server. This comes with infrastructure and IT staff time costs. The IT strategy states that we should be aiming to move to cloud hosted software.
- 8.4. As a result of these drivers for change, we started a procurement project in April 2023. At that time the expected costs were unknown (especially the split between revenue and capital costs), so were not incorporated in to the 2023/24 budget.
- 8.5 The tendering process resulted in bids from 3 suppliers, and all 3 suppliers were invited to provide full demonstrations of their products. The scoring of the contract was based on 60% quality (including 10% for the demonstrations), 30% price and 10% social value. There was a requirement for all suppliers to meet a minimum threshold score across all of the various sub-components of the software.
- 8.6 The winning bidder scored more highly across all the areas for evaluation, providing the Council with the most economically advantageous bid.
- 8.7 The winning solution will have a small increase in the current revenue (annual) cost. This can be covered with staff savings that have already been identified. As it is a new system it will require up-front development work. It is estimated that this will be around £200k, but will depend on the number of hours work required. This cost can be capitalised. The initial contract period is 10 years, so even writing off over that period would equate to an equivalent annual cost of £20k. It is fully expected that further cashable savings will be delivered which will off-set this amount (e.g., in IT infrastructure costs and staff time when vacancies occur). There will also be non-cashable savings from other process efficiencies that reduce the time spent on current tasks. It also avoids increases in the cost of the current software.

#### 9. LEGAL IMPLICATIONS

- 9.1 As the contract value is above the WTO GPA threshold, the Public Contract Regulations 2015 apply, which was the reason for selecting an Open Tender Process.
- 9.2 Under 14.6.12 (a) (i) the Service Director- Resources will "manage, direct and control all resources allocated to the Directorate in accordance with the Council's policies". Under 14.6.4 (a) (ii) of the Council Constitution, Service Directors have a general authorisation for "entering into contracts to carry out works and/or for the supply of goods and services within approved budgets".
- 9.3 Legal will assist the Officer in preparing the final form of contract.

#### 10. FINANCIAL IMPLICATIONS

- 10.1 As detailed in the report the revenue (annual) cost of the new software contract is slightly higher than the current software contract costs and budget. The increase can be covered by already identified savings that arise from process efficiencies.
- 10.2. There is an implementation cost that is estimated at £200k. This cost can be capitalised. Council have approved that this is added to the 2023-24 capital programme.

#### 11. RISK IMPLICATIONS

11.1 The implementation of a new finance system is a significant piece of work. The provider will be required to carry out all the technical work, but it will still require significant input from relevant officers. There is a risk that there will be complications with the implementation, but these are mitigated by the positive references that we have received. The implementation of the new software will be over a period of 12 months up to Autumn 2024.

#### 12. EQUALITIES IMPLICATIONS

- 12.1 In line with the Public Sector Equality Duty, public bodies must, in the exercise of their functions, give due regard to the need to eliminate discrimination, harassment, victimisation, to advance equality of opportunity and foster good relations between those who share a protected characteristic and those who do not.
- 12.2. There are no known equalities implications relating to this decision.

#### 13. SOCIAL VALUE IMPLICATIONS

- 13.1 The recommendations in the report are linked to a contract above £50,000. Social Value was incorporated in to the contract with an assessment weighting of 10%. The winning provider has agreed to provide the following Social Value:
  - 10 hours per annum of free IT/ Financial advice provided to the voluntary sector and small businesses, with a focus on supported disadvantaged young people.
  - Donated equipment up to the value of 5% of the Annual SaaS Fee per annum. utilising their purchasing power to buy and donate equipment to the voluntary sector within North Herts.

#### 14. ENVIRONMENTAL IMPLICATIONS

14.1. There are no known Environmental impacts or requirements that are likely to apply to this report.

#### 15. HUMAN RESOURCE IMPLICATIONS

15.1 There will be some staffing efficiencies that will be enabled following the full implementation Some of the efficiencies that will be delivered as part of this decision are expected to be a reduction in staff hours. These are generally expected to be managed through not filling vacancies when they arise, but, if necessary, the Council's reorganisation policy will be applied. There are also expected to be small time savings for other Officers that then give more time to complete other tasks.

#### 1. DECISION TAKEN

To approve a variation and extension to the contract awarded to Hyas Associates to continue to provide specialist planning advice and project management support on strategic development sites.

#### 2. DECISION TAKER

Ian Fullstone, Service Director - Regulatory

#### 3. DATE DECISION TAKEN:

28 September 2023

#### 4. REASON FOR DECISION

4.1 To allow Hyas to continue supporting the Council in relation to a strategic masterplan for the East of Luton allocations contained in the adopted Local Plan.

#### 5. ALTERNATIVE OPTIONS CONSIDERED

5.1 To not extend the support. This has been rejected as it would leave the Council with insufficient capacity to participate in a collaborative masterplanning process with the landowners (and their representatives) for these sites. The allocations are a key element of the Local Plan which is part of the Council's Policy Framework (as defined by the Council Constitution) and the statutory Development Plan for the purposes of determining planning applications.

### 6. CONSULTATION (INCLUDING THE EFFECT ON STAKEHOLDERS, PARTNERS AND THE PUBLIC)

6.1 This decision has been taken in consultation with the Service Director – Resources and the Executive Member for Planning in line with the Council's Contract Procurement Rules.

#### 7. FORWARD PLAN

7.1 This decision is not a key Executive decision and has therefore not been referred to in the Forward Plan.

#### 8. BACKGROUND/ RELEVANT CONSIDERATIONS

- 8.1 Masterplanning is widely recognised and supported, including in Government planning guidance, as a means of identifying and addressing issues on large-scale sites and setting out a framework for their development.
- 8.2 Hyas Associates were procured under Single Tender Waiver (STW) in August 2021 to "provide expert support for the masterplanning and delivery of strategic and significant development sites in the District".

- 8.3 This was intended to support, and has been deployed to progress, the masterplan for proposed East of Luton development. These sites are allocated for up to 2,100 homes and supporting infrastructure by Policy SP19 of the Council's adopted Local Plan. The policy requires a masterplan for the site to be agreed prior to, or as part of, the grant of planning permission.
- 8.4 Due to delays (i) in completion of the Local Plan and (ii) on this project from the landowner side, the support has extended over a significantly longer period than was initially envisaged.
- An updated contract covering the residual of the support was signed in September 2022 for the period to 1 April 2023. That was extended in March 2023 to cover the period to 30 September 2023. To date, the invoiced support from Hyas relating to this STW and project totals approx. £46,200. This broadly aligns with the values identified in the STW and the contracts.
- 8.6 Given the delays in the programme, on-going support is required from Hyas to see the masterplan through to completion. Hyas have provided an estimate for up to £16,120 of additional support based upon approx. 1 day per week support over the next six months to be deployed flexibly as required (excluding VAT and reasonably expenses).
- 8.7 The Council's Procurement Officer has advised that, in the circumstances, it is appropriate to secure this additional support by means of an extension / variation to the contract. This is being progressed in line with the Council's Contract Procurement Rules.
- 8.8 If proceeded with and utilised in full, the extension / variation will bring total anticipated expenditure with Hyas Associates on this project to approximately £62,000. This exceeds the £50,000 threshold for a Recorded Decision.
- 8.9 There is no reasonable alternate to continuing the use of Hyas given their significant accumulated knowledge of the project to date and the requirement for continued capacity support across the planning services.
- 8.10 There is sufficient funding to meet the overall / additional cost from a combination of Government grants and landowner funding from an agreed Planning Performance Agreement (PPA). The PPA contains a review mechanism which can be triggered to consider costs once the project reaches the draft Masterplan stage.

#### 9. LEGAL IMPLICATIONS

- 9.1. Sections 28 and 29 of the Council's Contract Procurement Rules set out the approach(es) to be followed and the conditions to be met in varying or extending an existing contract.
- 9.2. The Procurement Officer has confirmed that the relevant conditions are met for the Service Director, following consultation with the Service Director: Resources and the relevant Executive Member, to vary and extend the contract with Hyas Associates.
- 9.3. Contractual documents have been drawn up by the Council's Contracts Lawyer.

#### 10. FINANCIAL IMPLICATIONS

10.1. There are no new revenue implications. Expenditure to date has been met from a one-off grant from the (then) Ministry for Housing, Communities and Local Government (MHCLG) to be utilised on schemes for 2,000 homes or more and from funding towards the masterplan secured from the landowners and their representatives through a Planning Performance Agreement (PPA).

10.2 There is sufficient funding to meet the overall / additional cost from a combination of Government grants and landowner funding from an agreed Planning Performance Agreement (PPA). The PPA contains a review mechanism which can be triggered to consider costs once the project reaches the draft Masterplan stage.

#### 11. RISK IMPLICATIONS

- 11.1 Masterplanning is an identified risk on the Council's framework. The identified risks are:
  - Risk of poor scheme outcomes that do not appropriately respond to local character and context.
  - Risk that strategic sites do not maximise contribution to corporate objectives and priorities of climate change, environment, economy and place.
  - Risk of delay to delivery of strategic sites if masterplan process is delayed or stalled or provides insufficient information to guide subsequent planning applications.
  - Failure to secure funding to resource the process.
  - Reduction in pre-application income and delay to income from planning applications.
  - Failure to recruit sufficiently experienced officers.
  - Risk of adverse appeal findings on other/non-Local Plan sites if delivery is delayed or stalled.
- 11.2 Securing continued and ongoing support from Hyas Associates is a means of managing and mitigating these risks for the East of Luton allocations.

#### 12. EQUALITIES IMPLICATIONS

12.1 None.

#### 13. SOCIAL VALUE IMPLICATIONS

13.1 As the recommendations in the report relate to a contract below £100,000 the "go local" policy has been considered but has not been applied as this is a variation / extension to a pre-existing contract.

#### 14. ENVIRONMENTAL IMPLICATIONS

- 14.1. None.
- 14.2. The allocation of the sites in the Local Plan was informed by a statutory Sustainability Appraisal of the likely social, economic and environmental effects that was considered by the Inspector as part of the Examination.
- 14.3. Due to their scale, any application(s) on these sites would likely represent EIA Development and would be accompanied by a statutory Environmental Statement.
