# MEMBERS INFORMATION NOTE

#### **Safeguarding Training**

Safeguarding relates to the action taken to promote the welfare of children and adults at risk and protect them from harm.

Safeguarding is everyone's responsibility and all NHC employees, volunteers and members have a duty to take action to safeguard children and adults at risk in our communities.

NHC offers two levels of training and the level of training required is determined by how much contact, be that direct or indirect (email, telephone, post etc.) you have with children and adults including access to personal and sensitive information about them.

The levels of training are:

#### Basic

- a 3-hour long course which is required to refresh every 3 years.
- This is for any member that has contact, either directly or indirect with children and adults and/or access to personal and sensitive information.
- There are separate basic courses for children and adults at risk.

#### **Advanced**

- a 6-hour course which is required to be refreshed every 3 years.
- This is for any member who manages another member or is a Designated Safeguarding Officer.
- There are separate advanced courses for children and adults at risk.





# **Green Space Briefing Note No 217**

#### December 2023 & January 2024

As we move into the festive period the scope of work for Greenspace changes along with the seasons.

Grass cutting is ongoing but at a much-reduced rate and only where ground conditions permit. The mild autumn has resulted in grass growth later into the year than we would normally expect.

Leaf collection is underway and will be ongoing until the New Year. Greenspaces undertake the service for Settle Housing in their Sheltered Housing Schemes, within our parks and cemeteries. The street scene is maintained by Urbaser as part of the Street Cleansing Contract.

Over the winter period several hedges have been identified for reduction which have become too large for their location or are causing issues such as blocking sightlines etc. This work will ensure the longevity of the hedge and that it continues to provide a secure boundary. This work will be ongoing on an ad hoc basis throughout the winter as weather conditions and resources permit.

Herts County Council are once again undertaking to give away trees to residents across the County. In North Herts 3,000 trees had been allocated for our residents. NHC has topped this up by a further 5,000 trees providing a total of 8,000 trees for our residents this year. We are working with Herts County Council to deliver something similar next year.

Greenspace has identified one hundred trees to be planted to replace those that have been lost over the last year due to storm damage, old age or disease in our parks, open spaces, and highway verges within the urban areas of the district. These replacement trees will be planted in the New Year as and when weather conditions permit.

#### **Baldock**

The grazing long horn cattle have now been removed from Ivel Springs and Weston Hills for the winter

The augmentation project at Ivel Springs that is being delivered by Affinity Water is currently underway and is on target for completion at Christmas.

#### Letchworth

The tender for the replacement of the bridge near the small marsh is now public with site visits already completed with interested parties.

In liaison with families, we have undertaken four memorial tree planting at Wilbury Hills Cemetery which compliments the layout and planting plans of the site.

#### Hitchin

St John's Cemetery is now full and therefore future burials for Hitchin will be redirected to Wilbury Hills Cemetery. St John's Cemetery will still accept burials for those families that have pre purchased a grave plot or for a second burial in a family grave where space permits. Interment of cremated remains will also be available for the near future. The initial surveys and development of a detailed design to deliver the Environment Agencies preferred option for replacing Oughtonhead Weir are underway and will be on going into spring. The project for the renovation of Bancroft Recreation Ground play area is now out to tender and should be awarded early in the New Year.

#### Royston

A contract has been tendered for the replacement of an old climbing frame at Serby Ave. This contract will be awarded in the New Year to replace the existing old item with a new modern one that provides more play value and greater interest to visitors.

The new climbing tower at Priory Memorial Gardens has been the focus of vandalism over the last month and has required several repairs and replacement parts are order. This situation has been brought to the attention to the local Police which is being monitored.

#### **Council Activity**

#### **Home Upgrade Grant Phase 2 (HUG2)**

Home Upgrade Grant Phase 2 is now live and the webpage is live. Residents can now sign up via the hug website or by calling the energy Saving Trust. Further mailouts will follow to target areas. Home Upgrade Grant Phase 2 | North Herts Council (northherts.gov.uk)

#### **Solar Together**

The second round of Solar Together has now closed for registrations. North Herts have received a total of 898 registrations so far. Registrants will now receive offer recommendations and will have up until the 15<sup>th</sup> December to accept offers. 159 households have accepted their recommendation. The price achieved for the average 14-panel system within this scheme is 34% cheaper than the typical market price for an equivalent system. Solar Together | North Herts Council (north-herts.gov.uk)

#### **Climate Hive Engagements**

We want to hear more from residents on sustainability and have launched two engagements for residents to tell us how they have saved money on their energy bills and also how they plan to have a more sustainable Christmas. The Climate Hive now has over 300 subscribers and we continue to update users with the latest climate activity such as the HUG2 launch, COP28 and use of Thermal Imaging Cameras. We encourage staff to also take a look at the Hive engagements and post any tips they may have too.

#### **Biodiversity Duty**

We have begun conversations with officers from Greenspace, Planning and Planning Policy around compiling our Biodiversity duty, due in January 2024 which will cover what actions we can take as a council to support biodiversity enhancement and to agree policy and objectives.

#### **Community Investment Fund**

The Community Investment Fund is now closed. Applications will now be reviewed.

## **Energy Act 2023**

#### **1 Executive Summary**

The Energy Act received Royal Assent on 26<sup>th</sup> October 2023.

This briefing provides a summary of the Act and an APSE Energy comment. The government highlights that the Act will help ensure energy is affordable for households and businesses and make the UK more energy independent in the long-term; help unlock £100 billion private investment in energy infrastructure and scale up jobs and growth and sets measures to accelerate development of offshore wind and help deliver our net zero commitments.

The Act applies to the UK.

#### 2 Main announcements

The government statement notes that the "Act will deliver a more efficient energy system in the long-term, helping to keep energy costs low. It will do this by increasing competition in Great Britain's onshore electricity networks, through a new tender process – reducing costs for network operation and development. This new model is expected to save consumers up to £1 billion off their energy bills by 2050" and "help the government deliver net zero by 2050 in a pragmatic, proportionate and realistic way".

A series of highlights are noted below with accompanying comments from the government announcement of the Act coming into law.

A specific merger regime for energy networks will be created under the Competition and Markets Authority. This will minimise the risk of mergers between energy network companies having detrimental effects on consumers and is estimated to save households up to £420 million over the next decade.

There are also new measures for Energy Smart Appliances to prioritise safety and give consumers the confidence to transition to smart products, helping them to manage their energy consumption and reduce their bills. A smart electricity system could reduce system costs by up to £10 billion a year by 2050.

The government is expanding Ofgem's remit to regulate heat networks for the first time, allowing the regulator to set rules on excessive pricing and improve the quality of service for the half a million heat network consumers across the country.

The new laws will facilitate the first large village hydrogen heating trial – providing crucial evidence on the technology's role in decarbonising heat.

Additionally, a licencing framework for CO2 transport and storage will be introduced. This will support the delivery of the UK's first carbon capture sites – supporting up to 50,000 jobs by 2030.

The Act includes new consumer protections and frameworks, incentivising the heating industry to invest in low-carbon heat pumps. It includes powers to deliver smart meter rollout by 2028 – which could generate total bill savings to households of £5.6bn, the government claims.

The Energy Act 2023 also includes provisions aimed at boosting the nuclear sector and making the UK the first country to legislate for fusion regulation, enabling developers to plan new facilities to potentially make fusion power a reality and drive ambitions for a prototype fusion power plant by 2040.

The Act also establishes a new independent body – the Future System Operator – which will ensure consumers can access a secure and decarbonised energy supply, key to enhancing the country's energy security. The FSO will be responsible for systems in the gas and electricity network developing efficiently and keeping consumer bills low.

The Act gives powers to D-ESNZ to deliver government supported business models for both hydrogen production and Bioenergy Carbon Capture and Storage (BECCS).

#### 3 Ofgem

The Act provides Ofgem with a statutory net zero duty which restates Ofgem's principal objective to protect the interests of existing and future energy consumers and adds a specific mandate to achieve it by supporting the Government to meet its legal obligation to get to net zero by 2050. The Act overall gives Ofgem new powers to protect consumers and reach net zero – by unlocking investment, accelerating planning decisions, building new infrastructure and paving the way for innovation and technology.

New responsibilities and powers for OFGEM include:

- Net zero duty: amending the regulator's existing duties by including reference to the
  net zero targets and five-year carbon budgets in the Climate Change Act 2008. This
  requires Ofgem to consider how its decisions may assist the Secretary of State in
  meeting the government's net zero target, while protecting the interests of existing
  and future consumers. Ofgem welcomed the Government decision in June 2023 to
  include the duty in the Act;
- New system operator: establish a Future System Operator and Independent System
  Operator with responsibilities in both the electricity and gas systems, ensuring
  efficient energy planning, enhancing energy security, minimising cost to consumers

and promoting innovation. The Bill imposes a duty on the Future System Operator to respond to requests for advice, analysis or information from government or Ofgem;

- Heat networks: appointing Ofgem as the new regulator for heat networks in Great Britain:
- Energy codes: new governance framework for energy codes this will move responsibility from industry committees to "code managers" directly accountable to Ofgem. This will give Ofgem strategic powers to protect consumers and create competition;
- Hydrogen transport and storage: establishing new business models for hydrogen transport and storage to remove market barriers, like high upfront costs, and unlock investment with long-term revenue stability;
- Multi-purpose interconnectors: introduce a new legal definition for multi-purpose interconnectors into the Electricity Act 1989;
- Energy intensive industry: give government powers to compensate energy intensive industries for a portion of their network charging costs – funded via a charge on all licenced electricity suppliers called the EII Support Levy;
- CO2 transport and storage: establishing an economic regulation model with statutory objectives and legal powers for Ofgem as the economic regulator of CO2 transport and storage. This will unlock private finance and remove investment barriers for novel technology.

#### 4 APSE Energy Comment

This is a wide-ranging Act and the fact that it brings added focus to the energy sector is of course welcome by all those involved. However, it does raise questions about how the situation which we find ourselves in now was allowed to develop and also about the level of ambition within this Act. In other words, does the Act go far enough to ensure we do not find ourselves in the position we are in now, in a few years' time.

The government statement accompanying the news of the Act stated "The Act will help the government deliver net zero by 2050 in a pragmatic, proportionate and realistic way". This mirrors the wording in the prime minister's speech on 20th September when announcements such as moving the ban on buying new ICE vehicles 5 years into the future and ending plans to force landlords to upgrade the energy efficiency of properties were made. These attracted significant criticism by many in the low carbon sector as a form of dumbing down on ambition.

The Energy Security Secretary, Claire Coutinho said that "The Energy Act is the largest piece of energy legislation in a generation. It will boost investment in clean energy technologies and support thousands of skilled jobs across the country". It remains to be seen of course

whether these outcomes will materialise but they must if we are to meet UK targets. The skills issue is significant and one that any local authority officer will have come across who has for example, tried to engage a supplier to install or maintain a heat pump. There is a desperate need to train the people required to take a low carbon economy forward and resources must be found to enable it.

The introduction of a merger regime for energy networks is welcome. Minimising detrimental effects on customers should include fair pricing as well as protecting them from having to pay for future costs of network upgrades. It is vital to ensure a position where energy network companies are held responsible for maintaining the network and as such a merger regime should be one method of enabling this.

It is well recognised that there is a requirement for a range of technologies and business models to reach the national targets we have set ourselves and that conditions exist to attract investment from the private sector alongside public sector funding streams. The elements of the Act dedicated to sectors such as hydrogen, carbon capture and storage, nuclear and infrastructure should provide some certainty for those looking to invest significant sums and that is to be welcomed. Contributions are required from investors, suppliers, innovators, academic and training organisations as well as local and central government and we all have a role to play.

The Act sets down the strategic way forward and the ambitions and descriptions in the announcements accompanying the Act are encouraging. It is of course down to another group of public sector organisations, including local authorities, and commercial companies to take the agenda forward.

#### **Shared Prosperity Fund Grants for Town Centre Improvements**

Further to the Grants funded by the North Herts Shared Prosperity Fund in support for Improvements in our town centres and High streets in June 2023, the Executive Member for Enterprise has authorised further grants from the fund as follows:

Hitchin BID - £6,000 towards the updating and renewal of the lighting and suspension systems supporting the Christmas lights and other displays. This is in addition to the £25,100 already paid to Hitchin BID from the Shared Prosperity Fund.

Royston Town Council – a further £3,141.42 to complete the project to repair and repaint the street furniture in the town centre. Royston Town and BID have already received £24,350.

North Herts Council are spending £12,420 for the town centre monitoring systems annual fee. This is a requirement of the Shared Prosperity Fund .

#### 3. REASON FOR DECISION

- 3.1 In July 2022, North Herts Council (NHC) compiled the North Herts Shared Prosperity Fund (SPF) Investment Plan, which provides details of our plans to distribute the 3 annual allocations of the fund provided by the Department of Levelling Up, Housing and Communities (DLUHC) to projects and programmes for the betterment of the District under the scheme.
- 3.2 In the investment plan, NHC allocated funding towards Improvements to town centres and high street (investment priority E1) as follows:

2022/3 £76,702 2023/4 £51,404 2024/5 £229,438

- 3.3 The Investment Plan was approved by DLUHC in Dec 22/Jan23 and NHC received the 2022/3 allocation in Feb 2023. NHC received the 2023/4 allocation in July 2023.
- 3.4 Following the first round of town improvement grants, NHC have identified a balance from 2022/3 and 2023/4 of £25,877which must be spent prior to the end of March 2024. Stakeholders were asked to submit further proposals to spend the money.
- 3.5 The Stakeholders have submitted their proposals, and NHC have prioritised urgent requirements to be included in the 2023/4 Town Centre tranche. These are outlined in Section 5 below for approval.
- 3.6 Following approval, NHC will pay the grants to the stakeholders who will be responsible for delivery of and reporting on the approved projects.
- 3.6.1 These activities are all designed to fall under the 'E1 intervention, Improvements' to the town centres and high streets.

#### 3.6.2 Required outcomes

The outputs and outcomes chosen to reflect the success of the measures by March 2025 are :

- a) Increased Footfall (at least 5%)
- b) Improved public realm space (in m2)

We will require feedback from the grant recipients, coupled with our use of the Community Vision Town Centre metrics system to report back to DLUHC.

3.6.3 We will require the grant recipients to procure items in accordance with the SPF guidance, furnish NHC with invoices representing all spend and to return any underspend that may occur.

#### 4. CONSULTATION WITH MEMBERS

4.1 Consultation will take place by means of an information note that published in the Members Information Service on the 1<sup>st</sup> December 2023.

#### 5. APPLICATION DETAILS

NHC is required to monitor to progress of improvements in town centres under the SPF Programme. In order to provide consistent metrics we would like to extend our contract with HUQ for provision of the Community Vision system which provides data on footfall, dwell time, demographics and other data. The 2023 annual cost was £11,840, paid from the 2022/3 allocation. It is proposed to renew the contract at the end of December 2023 at a cost of £12,420, a 5% increase. This will give NHC access to the next generation Signal system produced by HUQ which will give us greater accuracy in metrics and allow our partners and stakeholders their own direct access to the system, at an additional cost of 15%.

We have also contracted centrally with People and Places Partnership who compiled the recent Town Centre studies to enable further work with stakeholders to crystalise and enable them to start to implement their Town Centre Improvement programmes in Letchworth, Baldock and Royston. The total cost is up to £24,000 over the 18 months to October 2024. The Letchworth Heritage Foundation have pledged a further £2,000 to match the work undertaken in the town.

It appears that People and Places are likely to invoice NHC for £8,000 in 2023/4 and so we propose to roll the balance of £16,000 over to the 2024/5 budget.

- 5.2 Hitchin BID have requested £6,000 towards the £12,050 cost of renewing lighting suspension and connection system. The remainder of the balance will be provided by BID, the Hitchin Area forum and member's locality budget.
- 5.3 Royston Town Council have completed the original Street furniture renewal and repair project. They have found that some items were not included in the original quotation, and so have requested a further grant for the completion of the project. This amounts to £3, 141.42.

#### 6. LEGAL IMPLICATIONS

6.1 Chapter 1, s1-8 of the Localism Act 2011 provides a General Power of Competence which gives local authorities the powers to do anything if it is not specifically prohibited in legislation.

- 6.2 Section 137 Local Government Act 1972 provides specific authority for the Council to incur expenditure on anything which is in the interests of and will bring direct benefit to its area. This includes a charity or other body operating for public service.
- 6.3 The decision taker signing the Decision Notice has delegated authority to take such a decision in accordance with the North Hertfordshire District Council Constitution under section 14.6.8(b)(iii)(A) in relation to Community engagement and development, including financial assistance and grants to external organisations.

#### 7. FINANCIAL IMPLICATIONS

- 7.1 The current balance available in the Shared Prosperity budget and North Herts District Investment Plan to allocate towards Town Centre Improvements is £411,245 over years 2022/3, 2023/4 and 2024/5 from the Department for Levelling Up, Housing and Communities.
- 7.2 The Allocations as outlined in section 6 represent a capital spend of 28%, well inexcess of the 13% total allocation minimum required by DLUHC.

#### 8. RISK IMPLICATIONS

8.1 There are no relevant risk entries that have been recorded on Pentana Risk, the Council's performance and risk system. Individual events should have their own risk assessments in place to mitigate any health and safety issues. Whenever a request for grant funding for equipment is received, the recipient of the funding will be advised to obtain insurance for the item to avoid a repeat request for funding in the event of the equipment being stolen or damaged. There are no pertinent risk implications for the Authority associated with any items within this report.

#### 9. EQUALITIES IMPLICATIONS


