DISCLOSABLE PECUNIARY INTERESTS & DECLARABLE INTERESTS

The Register of interests is maintained by the Monitoring Officer at North Hertfordshire District Council in accordance with section 29 of the Localism Act 2011. It is a Councillor's responsibility to notify the Monitoring Officer of their interests and keep the Register up to date within 28 days of election or appointment or of any changes.¹

Sponsorship/ other payments received in respect of your role as a Councillor Any payment or provision of any other financial benefit made or provided within the last 12 months in respect of any expenses incurred by you in carrying out duties as a Councillor or towards your election expenses. This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992. You are not required to declare allowances or expenses received from your Council on this form.

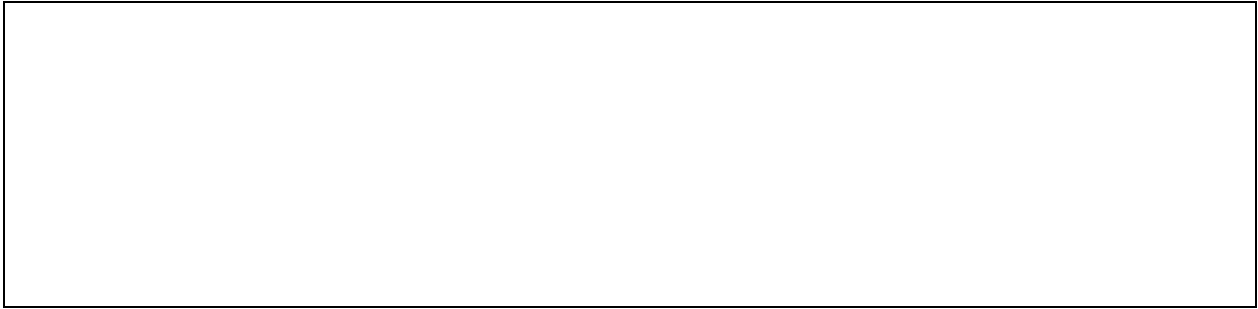




I have noted that it can be a criminal offence under the Localism Act 2011 and a potential breach of my Council's Code of Conduct to:-
