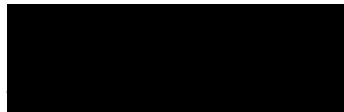
I have noted that it can be a criminal offence under the Localism Act 2011 and a potential breach of my Council's Code of Conduct to:-
